The meeting opened with the pledge to the flag led by Mayor Shayler.

Mayor Shayler stated the first order of business is the acceptance and approval of the minutes from the Regular Meeting held February 27, 2017. Trustee Ketchner made a motion to accept the minutes and Trustee Herman seconded the motion. Carried.

WHEREAS, the Village of Wellsville Trustees has approved the 2016-2017 Annual budget which includes a Capital Plan and, in discussion with the Department of Public Works, has deemed it necessary to replace and repair the Fire Hall Boiler System, and

WHEREAS, the price of these repairs is approved for an amount that shall not exceed Twenty Thousand Dollars (\$20,000) and shall be appropriated from the General Fund Capital Reserves, and

WHEREAS, this resolution is subject to permissive referendum, unless emergency replacement is needed, per public notice which will be given through the official newspaper within 10 days and which would require 20% of the registered voters as of the last election to file a petition with the village clerk.

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Village of Wellsville does hereby authorize the replacement and repair of the Fire Hall Boiler System as described.
