The meeting opened with the pledge to the flag led by Mayor Shayler.

Mayor Shayler stated the first order of business is the acceptance and approval of the minutes from the Regular Meeting held on April 24th, 2017. Trustee Fahs made a motion to accept and approve the minutes and Trustee Ketchner seconded the motion. Carried.

Mayor Shayler opened the floor to Darwin Fanton, Alternate Town Planning Board member. Mr. Fanton announced the Town Planning Board was approached to support "disc golf" being added to the Lagoon Area near the horse shoe pits. At first, the plan would be to setup 9 holes to study how many people in the area would be interested in participating. Mr. Fanton stated there will be a demo of sort at the County Fair Grounds on May 6th and 7th, 2017.

- 1. Mayor Shayler thanked everyone for their time spent preparing this year's budget and the successful reduction of the tax rate.
- Mayor Shayler requested consideration and approval to schedule a joint Town and Village Comprehensive Plan Meeting to be held May 10th at 6:30 pm in the Village Board Room. Trustee Ketchner made a motion to approve the request and Trustee Fahs seconded the motion. Carried.
- 3. Mayor Shayler made a motion to change the regular board meeting from Monday, May 8th, to Wednesday, May 10th immediately following the joint hearing. Trustee Cole seconded the motion. Carried.
- 4. Mayor Shayler presented the Arbor Day Proclamation:

PROCLAMATION

WHEREAS, In 1872 J. Sterling Morton proposed to the Nebraska Board of Agriculture that a special day be set aside for the planting of trees, and

WHEREAS, this holiday, called Arbor Day, was first observed with the planting of more than a million trees in Nebraska, and

WHEREAS, Arbor Day is now observed throughout the nation and the world, and

WHEREAS, trees can reduce the erosion of our precious topsoil by wind and water, cut heating and cooling costs, moderate the temperature, clean the air, produce oxygen and provide habitat for wildlife, and

WHEREAS, trees are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products, and

WHEREAS, trees in our cities increase property values, enhance the economic vitality of the business areas, and beautify our community, and

WHEREAS, Wellsville, New York has been recognized as a Tree City USA by the National Arbor Day Foundation and desires to continue its tree-planting ways,

NOW, THEREFORE, BE IT RESOLVED that I, Randy M. Shayler, Mayor of the Village of Wellsville do hereby proclaim April 28, 2017 as Arbor Day in the Village of Wellsville, and I urge all citizens to support efforts to care for our trees and woodlands and to support our Village's Community Forestry Program, and

FURTHER, I urge all citizens to plant trees to gladden the hearts and promote the well-being of present and future generations.
