The meeting opened with the pledge to the flag led by Trustee Herman.

Mayor Shayler opened the floor to Donald Latten. Mr. Latten commented on his neighbor is finally mowing his lawn. Mr. Latten asked if it was possible if the Village could do anything to allow public parking in the Proto lot (across from the Texas Hot). Mayor Shayler stated that was public property and the Village is unable to do anything about it.

Mayor Shayler addressed Mr. Weinhauer's request about having his block party, July 29th. Mr. Shayler stated the Village may be having construction going on about that time on Main Street and Mr. Weinhauer may have to have extra security for his party. Mr. Weinhauer stated there are no changes to the program from the last two years. Mr. Weinhauer said having more security on hand would be no problem. Mayor Shayler made a motion to accept the party request contingent upon working with Bill Whitfield around the construction. Mayor Shayler asked Mr. Weinhauer about the charities he contributes to. Mr. Weinhauer stated he donated part of the monies to St. Judes and Music on the Lawn. Trustee Herman seconded the motion. Carried.

- 2. Mayor Shayler announced the Legislators Clambake will be held from 1-6 pm on July 28th, 2017 at Island Park with the price of each ticket at \$40.00 each payable to "Allegany County Board of Legislators".
- Mayor Shayler requested a motion allowing Bokman to hold their 6th Annual Car Show on Saturday, July 22nd from 8am to 3 pm. Trustee Herman made a motion to accept the request and Trustee Fahs seconded the motion. Carried.

WHEREAS, the Village of Wellsville Trustees has approved the 2017-2018 Annual budget which includes a Capital Plan, and

WHEREAS, the Village of Wellsville, in discussion with the Department of Public Works, has deemed it necessary to purchase a new Dump Truck for the Sewer Fund based upon the age and condition of the current fleet, and

WHEREAS, the purchase price of the Dump Truck in an amount that shall not exceed Eighty Thousand Dollars (\$80,000) which shall be appropriated from the Sewer Fund Capital Reserves, and

WHEREAS, this resolution is subject to permissive referendum per public notice which will be given through the official newspaper within 10 days and which would require 20% of the registered voters as of the last election to file a petition with the village clerk.

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Village of Wellsville does hereby authorize the purchase of a new Dump Truck.

AUTHORIZING NYSDOT TEP GATEWAY AGREEMENT

WHEREAS, a Project for the Transportation Enhancement Program: Wellsville Gateway Enhancements, P.I.N. 6754.81 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% federal funds and 20% non-federal funds; and

WHEREAS, the Village of Wellsville desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of the Transportation Enhancement Program: Wellsville Gateway Enhancements.

NOW, THEREFORE BE IT RESOLVED the Wellsville Village Board, duly convened does hereby

RESOLVE, that the Wellsville Village Board hereby approves the above-subject project; and it is hereby further

RESOLVED, that the Wellsville Village Board hereby authorizes the Village of Wellsville to pay in the first instance 100% of the federal and non-federal share of the cost of Design and Construction/Construction Inspection phase work for the Project or portions thereof; and it is further

RESOLVED, that the sum of \$469,000 is hereby appropriated from unassigned General Fund balance and made available to cover the cost of participation in the above phase(s) of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Village of Wellsville shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof; and it is further

RESOLVED, that the Mayor of the Village of Wellsville be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the Village of Wellsville with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and it is further

RESOLVED, this Resolution shall take effect immediately.
