The meeting opened with the pledge to the flag led by Village Clerk Wendy Seely.

Mayor Shayler stated the first order of business is the acceptance of the minutes from the Regular Meeting held on December 11, 2017. Trustee Cole made a motion to accept the minutes and Trustee Fahs seconded the motion. Carried.

Mayor Shayler opened the floor to the visitors present. Patty Johnson, as before, spoke on their behalf. The group consists of the residents from the South Broad Street and Miller Street areas, revisiting their concerns of the heavy truck traffic in their area and what can be done to reduce it. Discussion began with Trustee Monroe who shared information he obtained from the County and the Town, including the bridge on South Broad Street, noting that it currently does not list a weight limit and that any further questions would have to be directed to the County or Town as the bridge in not in the jurisdiction of the Village. Chief O'Grady added that the speed trailer was placed there for a week earlier this month. The results indicated a total of 1,061 vehicles passing by, averaging 184 per day. The busiest times were between 8:00 am and 1:00 pm on weekdays, averaging 7 MPH with a maximum recorded speed of 53 MPH. Ms. Johnson relayed the group's concerns regarding what the zoning is; concerns of potential contamination resulting from the industrial past; the continued damage to the roads, bridge and yards; who owns and/or maintains the property at the end of their street; and wanting their dead end back.

### MAYOR'S BUSINESS:

 Mayor Shayler announced the total revenue received from the parking meters collected over the holidays was \$1,891.18, which will be donated to the Wellsville Development Corp. for beautification, etc. Trustee Cole made a motion to round the figure to \$1,900. Trustee Ketchner seconded the motion. Carried.

**WHEREAS**, the Village Board has decided to treat the General Fund as a governmental fund and all other funds as enterprise funds (Electric and Refuse Funds have already been treated as enterprise funds);

**NOW, THEREFORE BE IT RESOLVED**, that the Village of Wellsville designates the Water and Sewer Funds as enterprise funds and will use accrual accounting procedures to account for these funds under the GASB 34 regulations.
