Deputy Mayor Ketchner requested acceptance of the minutes from the Regular Meeting held on September 24, 2018. Trustee Cole made a motion to accept the minutes and Trustee Monroe seconded the motion. Carried.

MAYOR'S BUSINESS:

1. Mayor Shayler was not present.

TRUSTEES' BUSINESS:

COLE:

- 1. Trustee Cole made a motion to accept and approve the vouchers as listed in the Abstract of Vouchers dated October 8, 2018. Trustee Fahs seconded the motion. Motion carried.
- 2. Trustee Cole requested executive session for an item of discussion.

MONROE:

1. Trustee Jeff Monroe, DPW Director Bill Whitfield and Wastewater Treatment Plant Chief Operator Mike Smith recently toured wastewater treatment plants in Dansville and Farmington. Jeff noted it was interesting and they got a lot out of the trip. Bill noted that MRB does those tours as well.

KETCHNER:

FAHS:

1. Trustee Fahs requested a brief executive session.

POLICE DEPT:

1. Trustee Fahs made a motion to approve the appointment of Evan Smith to permanent, full-time Police Officer effective 10/15/2018. Trustee Cole seconded the motion. Motion carried.

FIRE DEPT:

1. Chief Cavanaugh informed the Board of his applying for and receiving a grant through New York State, with assistance from Senator Young. The grant monies will be used for the purchase of a special dryer for turnout gear, valuing \$8,500. Grant money also paid for a generator for the Emerald Hook & Ladder Company. No new information on cancer coverage, but he's working to try to find ways to get the costs down.

DPW:

- 1. DPW Director Whitfield gave an update on the Madison Creek Culvert, noting three sections are in the ground; however, they came to a halt at a 4" gas main this week that had to be attended to.
- 2. Requested executive session for discussion of an item.

ATTY:

1. Attorney Synakowski was not present.

TREASURER:

1. Earl Johnson requested executive session to discuss a legal issue.

On a motion made by Trustee Cole and seconded by Trustee Monroe, the Board moved out of regular session and into executive session at 6:11 pm. Carried.

Trustee Cole made a motion to approve a downstream change order covering wall restoration for 35' in length, not to exceed \$40K using time and materials method. Trustee Fahs seconded the motion. Motion carried.

Trustee Cole made a motion for compensatory damages to the Toneys for property damage as a result of the Madison Creek culvert replacement for the amount of \$23,500. Trustee Monroe seconded the motion. Motion carried.

On a motion made by Trustee Fahs and seconded by Trustee Monroe, the meeting adjourned at 7:29 pm.
