The meeting opened with the pledge to the flag led by Trustee Monroe.

Mayor Shayler stated the first order of business being the acceptance of the minutes from the Regular Meeting held on February 12, 2018. Trustee Fahs made a motion to accept the minutes and Trustee Monroe seconded the motion. Carried.

Mayor Shayler welcomed the visitors present, asking for their topics of interest this evening. Mr. Sinclair noted that he had seen the agenda for this meeting and wished to attend, specifically interested in a water project update. Mr. Sobeck and Mr. Weinhauer were present to discuss a contractual issue in executive session. Mr. Culbertson attended tonight with the intent to answer questions related to his place of business, Jeff's Truck Repair, located near Miller Street, of which has been the topic of discussion in several previous Board meetings by residents of that area.

Discussion was held regarding the topics of concern brought up by the Miller Street residents. Mayor Shayler asked about what can be done to placate the residents and steps that can be taken to be the best neighbor he can be. Mr. Culbertson noted that he does make many efforts to keep truck traffic before 10pm, as well as ensure idling trucks are located as far away from the residential neighborhood as possible. Additionally, he often meets truck drivers at other locations, noting that he is not there to upset the neighbors and is aware of the issues they've brought up, trying to do what he can to make it better. Mayor Shayler thanked Mr. Culbertson for attending tonight's meeting, stating anything he can do to assist in the situation is appreciated.

WHEREAS, the Village of Wellsville desires to secure a consulting engineering firm to prepare a Bridge NY application on behalf of the Village for the location at Farnum Street over Madison Creek Culvert with the option of issuing a supplemental agreement to the selected consulting engineering firm to provide follow-on design and construction inspection services should these projects be awarded funding under the Bridge NY program, and

WHEREAS, the Bridge NY program is governed by the rules of the LDSA process established for federal-aid projects, and the Region 6 LDSA list of 15 firms shall be utilized to solicit proposals to provide the services described in the paragraph above and the solicitation for the consulting engineering firm must be a qualifications-based selection process pursuant to the LDSA rules, with negotiation of scope and fee occurring after selection of the preferred consulting engineering firm, and William Whitfield, Director of Public Works, is experienced in the LDSA process having overseen projects of a similar nature in the past;

NOW, THEREFORE BE IT RESOLVED, that William Whitfield, Director of Public Works, is authorized by the Village of Wellsville Board of Trustees to lead the LDSA solicitation process to select a preferred consulting engineering firm from the Region 6 LDSA list of 15 firms to prepare a Bridge NY application on behalf of the Village with the option of providing follow-on design and construction inspection services and to negotiate the scope and fee, and with Board of Trustee approval, enter into a subsequent contract,

with the preferred consulting engineering firm identified as a result of the qualificationsbased selection process.
