The meeting opened with the pledge to the flag led by Trustee Cole.

News; Chris Potter, The Spectator

Mayor Shayler requested acceptance of the minutes from the Regular Meeting held on May 13, 2019. Trustee Fahs made a motion to accept the minutes and Trustee Roeske seconded the motion. Carried.

Mayor Shayler offered the floor for visitors to speak. Trustee Ed Fahs introduced Chris Martelle, Wellsville Volunteer Fire Company President, and Andrew Gallagher, Dyke Street Engine Company President, and noted they were looking into a proposed merger. Ron Lanphier, Chairman, indicated that both companies had a preliminary vote in favor of merging; however, it's too early to state any additional facts. He spoke at length about manpower sharing, being easier to outfit three companies versus four, as well as the possibility of eliminating a piece of equipment. He indicated there are plans to meet with attorneys for further research into asset sharing, forming a new corporation, as well as the bylaws and constitutions. Mayor Shayler noted the Board's appreciation for them coming to the meeting to share this information.

Patty Graves, liaison from the Wellsville Town Board, addressed the Board asking for more information regarding the move to 23 North and if there will or will not be enough room for the Town staff to move there as well as the Village staff. She stated the last conversations about the blueprints was back in February when drawings showed a large area marked as commercial space, wondering if that was the intended location for the Town staff. However, new blueprints received by the Assessor did not show that space. Mayor Shayler indicated there had been a meeting with Alfred Housing last week and there was new talk of Alfred Housing being located at 23 North as well. Patty asked the Mayor if he had the authority to make changes to the blueprints or if that was in 2 Plus 4's hands as the owner. The Mayor indicated that yes, he does have that authority and that they want a final floor plan by June 30<sup>th</sup>. Patty stated that the Town needs to know the intentions so that they can make plans for alternative locations if they are not going to be at 23 North. Mayor Shayler shared that Alfred State architect students just recently completed some floor plan options that need to be examined. He believes there would be room for two of the three offices sharing space, but possibly not all three (Village, Town and Alfred Housing). He explained further that there have been some recent changes from 2 Plus 4, in that they are stating they weren't able to be approved for a PILOT so are now intending to charge a monthly lease of \$17,000, versus the original plan

of a \$0 lease, only having to pay utilities. Patty asked the Mayor how soon they could know more information and Mayor Shayler indicated by the 15<sup>th</sup> of June.

Mayor Shayler made a motion to accept and approve Resolution No. 18/19-22, to support a Local Waterfront Revitalization Program grant application, which if received, the Village Board is prepared to support the grant application with a 25% match in the form of in-kind and cash of approximately \$5,000 over two years.
