The regular board meeting opened at 6:00 pm with the pledge to the flag led by Mayor Shayler.

Trustee Fahs requested acceptance of the minutes from the Regular Board meeting held on May 10, 2021; Trustee Monroe seconded the motion. Carried.

Mayor Shayler welcomed everyone to the meeting, asking if anyone had anything to discuss. Roy Lafleur discussed the flooding that occurs on Williams Avenue every year, noting his family's frustration when their neighboring creek overflows, it floods into their home. He stated that no one comes out or does anything about it, even though it has happened repeatedly. He said it's not every year, but this time, the flooding came into his house, hallway and basement. DPW Director Whitfield stated that he knows that Brad Mattison has spoken with someone in that area, which Mr. Lafleur confirmed that he knows someone in the neighborhood had spoken with Mr. Mattison at some point about the situation. Patty Graves offered to have the Town Supervisor look into the situation as well, to see what part of the creek may be their responsibility and see what they can do to assist in cleaning it out. Mr. Whitfield said the Village has cleared it in the past, but hasn't been out there this year. Mayor Shayler asked Mr. Whitfield to check it out and come back with a status report at the end of next week.

### MAYOR'S BUSINESS:

1. Mayor Shayler gave thanks to the Electric crew (Ryan Stisser, Jeromy Foster, Jeff Gordon, Dalton Grimes) for successfully completing the scheduled Village-wide electric outage in the early hours of Sunday, May 23<sup>rd</sup>, as well as for the hours upon hours of assistance put into an unexpected outage due to a motor vehicle accident the Saturday prior. He continued with his thanks to the tons of people who were involved with the unexpected electric outage that postponed the scheduled one for a week. He noted that everyone jumped right in to assist, including Trustee Roeske, along with the Fire Police, who were directing traffic very soon after the accident occurred, causing the traffic lights to be temporarily out of commission; as well as hours of dedication from Assistant DPW Director Mattison and Village employees Dan Gardner, Sebastian Dunne, Kevin Murphy, and Austin Crawford, who were fully engulfed in handling numerous factors,

including setting up generators at the Waste Water Treatment Plant to keep its functionality intact. Thank you also to Trustee Ed Fahs for his tireless hours of work with National Grid. It was noted that some residents had electricity within six hours, while others went 24-30 hours without. The fire department, the police department, and the Department of Public Works employees all jumped right into action. Chief Tim O'Grady handled streams of information, while 13 line trucks, six bucket trucks, three digger trains, a digger pole setter, etc. were on site under the guidance of DPW Director Bill Whitfield. The Mayor added thanks for the fortunate chance that personnel from Arcade, Fairport, and O'Connell Electric were already in town for the planned power outage for the next day and were able to assist with the unexpected outage. He additionally noted his appreciation for the relationships with other municipalities, as well as with O'Connell Electric, in these times of need. Everyone stopped and took care of what had to get done. At meeting time, the Mayor noted that things were pretty much back to normal. He wrapped up with a "Hat's off" to all of the 50-plus people directly involved. And a special thank you to all who lost electricity.

- 2. Mayor Shayler made a motion to accept and approve the Wellsville Development Corporation's (WDC) request to place a Walsh Memorial Bench on Main Street in the Village in honor of former Police Chief Tim Walsh. Trustee Fahs seconded the motion. Carried. The Mayor requested that Trustee Fahs work with the WDC to determine the best place for the bench to be located.
- 3. Mayor Shayler noted receipt of the Wellsville VFW's 30-day Advance Notice of their renewal application for on-premises alcoholic beverage license as required by the State Liquor Authority. Their present license expires 9/30/2021. He stated that no action is required of the Board, unless anyone has a problem as a municipality of this renewal.
- 4. Mayor Shayler made a motion to accept and approve Resolution No. 21/22-03, subject to permissive referendum, To Purchase a Police Car. Trustee Monroe seconded the motion. Carried.

### TREASURER:

- 1. Treasurer Mullen discussed the bid results for the renewal of the \$231,000 Bond Anticipation Note currently held by Community Bank N.A. at a rate of 1.98%. First Citizens Bank (1.99%); Community Bank N.A. (1.50%); Greene County Commercial Bank (0.77%). She further noted that Municipal Solutions recommends using the low bidder, Greene County Commercial Bank. Mayor Shayler stated that he was not eager to approve that recommendation not knowing where that bank is located and based on an attorney recommending it. It was found that its headquarters is located in the Catskills, New York. Mayor Shayler made a motion to select Community Bank at 1.50%, stating that it is taxpayers money and this would be buying local. Trustee Roeske seconded the motion. Carried.
- Treasurer Mullen provided the Fire Department budget modifications for review, noting that they appear to be what is normally done this time of year. Trustee Monroe made a motion to approve the modifications; Trustee Fahs seconded the motion. Carried.

3. Treasurer Mullen requested executive session for a personnel matter.

Mayor Shayler discussed appointing Steven Pettenati to the Village Planning Board. Trustee Roeske made motion to accept and approve the appointment of Mr. Pettenati to the Planning Board; Trustee Monroe seconded the motion. Carried.

On a motion made by Trustee Fahs and seconded by Trustee Pearson, the Board moved out of regular session and into executive session at 6:54 pm. Carried.
