The Village of Wellsville is providing Bulky Trash Pickup on a weekly schedule now as of June 1, 2009. Fee is **\$20.00** regardless of quantity. Form must be submitted no later than NOON Friday of each week for pickups to be done the following week to the Village of Wellsville Clerk's office with payment.

* Junk automobiles, automobile parts, tires, liquid waste, animal wastes, computer equipment, televisions, toxic, flammable or explosive substances, lawn debris, twigs, branches and trees will not be collected.

All rules and regulations as noted in the local law on solid waste collection are in effect. This law is available on-line at www.wellsvillenyny.com or by request to the Clerk's office.

* Items shall be sorted in the following manner:

- A. Steel/Metal
- B. Trash (furniture, etc.)
- C. Lumber and wood wastes
- D. White Goods (refrigerators, washers, dryers, etc.)

* Collection will be made at curbside only. Village trucks will not enter private property.

* No Callbacks will be made to pick up materials set out after a street has been serviced for that group.

* Bulky items for collection must be at curbside by 6:00 am on the Monday of the week designated for pickup by this form. Trash will not be placed for collection more than 5 days prior to the planned collection.

* In the case of non-compliance with above noted regulations, the refuse will not be collected and the residents will be required to properly dispose of it within 24 hours after notification by the Village to do so. Non-compliance with these regulations will be considered a "violation" as defined in the Penal Law. Upon conviction, the penalty shall be a fine and/or imprisonment as allowed the the Penal Law.

* Customer must register for bulky trash pickup in advance. Payment shall be made at the Village Clerk's office.

* Waste lumber and/or wood must be in in lengths of 3 Ft. or less.
