Local Law No. 3 of 1996

A local law regarding rules and regulations in the Riverwalk Plaza

Be it enacted by the Board of Trustees of the Village of Wellsville as follows:

SECTION I

TITLE: This local law shall be known as "rules and regulations in the Riverwalk Plaza.

SECTION II

PURPOSE: It is the purpose of this local law to protect and promote the health, safety, and general welfare of the residents of the Village of Wellsville and to protect the property of the owners/tenants of the plaza.

SECTION III

DEFINITIONS:

RIVERWALK PLAZA shall mean the shopping complex bounded on the north by the Bolivar Road on the South by Seneca Street on the east by the Genesee River and on the west by properties owned by Van Mark Printing, Christian and Missionary Alliance Church, and Highland Health Care. SBL # 238.7-3-14.1 and 238.7-3-14.2 and 238.7-3-14.3.

THE RIVERWALK shall mean the pedestrian walk way along the west side of the Genesee River.

SECTION IV

SPEED LIMIT: All vehicular traffic will be restricted to 15 miles per hour within the plaza limits.

RECREATIONAL EQUIPMENT: Recreational equipment such as but not limited to roller skates, roller blades, skate boards and scooters are prohibited within the plaza limits. Roller Skates/roller blades will be allowed only on the Riverwalk.

OVERNIGHT PARKING: Overnight parking will be restricted

to employees and/or patrons of the establishments located within the confines of the Riverwalk Plaza limits.

ALCOHOLIC BEVERAGES: Open containers of alcoholic beverages are prohibited within the limits of the plaza.

TRAFFIC SIGNS: Vehicular traffic must obey all traffic signs within the limits, such as but not limited to STOP, YIELD, PEDESTRIAN CROSSING, HANDICAPPED PARKING.

FIRE LANES: For the purpose of establishing a fire lane, parking or standing of motor vehicles within thirty (30) feet to the front of the buildings within the limits of the Riverwalk Plaza is prohibited.

HANDICAPPED PARKING: Posted handicapped parking shall be permitted in designated spaces by permit only. Parking in said spaces without a permit is prohibited.

SECTION V

ENFORCEMENT: This local law shall be enforceable by the Village of Wellsville Police Department or any other agency empowered to enforce laws in the Village of Wellsville.

SECTION VI

PENALTIES: An offense against the provisions of this Local Law shall be punishable by a fine of not more than one hundred dollars (\$100.00).

SECTION VII

EFFECTIVE DATE: This local law shall take effect immediately upon filing with the Secretary of State.
