CHANGING SOLICITING AND PEDDLING LICENSE FEES

WHEREAS, a resolution was duly adopted by the Board of Trustees of the Village of Wellsville for a public hearing to be held on November 8, 2010 at 6:45 p.m. to hear all interested parties on a proposed resolution to change soliciting and peddling license fees; and

WHEREAS, notice of the public hearing was duly advertised on October 29, 2010 in the Wellsville Daily Reporter, the official newspaper of said Village; and

WHEREAS, the public hearing was duly held on November 8, 2010 at 6:45 p.m. at the Municipal Building, 156 North Main Street, Wellsville, New York 14895, and all parties in attendance were permitted to speak on behalf of or in opposition to the proposed resolution or any part thereof; and

WHEREAS, the fees for soliciting and peddling licenses have been at the current levels Since 1985; and

WHEREAS, the Board of Trustees of the Village of Wellsville, after due deliberation, finds it in the best interest of the Village of Wellsville to raise the license fees for soliciting and peddling as follows:

Peddling:	\$50.00	\$150.00	\$700.00	exempt

NOW, THEREFORE, BE IT RESOLVED, that hereafter, soliciting license fees and peddling License fees shall be as follows:

1-3 days	4-30 days	31 days to 1 year	Schools & Church

Soliciting:	\$50.00	\$150.00	\$700.00	exempt
Peddling:	\$50.00	\$150.00	\$700.00	exempt
